March 7, 1972

Patrick Hart to Trustees

Letter gives background information on *The Inner Experience*.

December 28, 1973

Norman Kramer to Trustees

Letter is to confirm an extension of a clause in a contract between the Trust and Kramer.

May 28, 1974

James Laughlin to Trustees

A request to let "Emblems of a Season of Fury" to go out of print since it was to be in the *Collected Poem*, but to allow for "Geography of Logaire" to be reprinted.

February 28, 1975

James Laughlin to Trustees

A letter about Miguel Grinberg's unauthorized Merton "Mensajes" pamphlet in Argentina.

April 8, 1975

Robert Daggy to Trustees

Letter mentions the policies in place at Bellarmine in regards to the Merton correspondence.

April 9, 1975

Robert Daggy to Trustees

Letter is a clarification about the document concerning the policies regarding the Merton correspondence.

April 11, 1975

John Teahan to Trustees

Letter contains a request to use the material at the Merton Studies Center for a Ph.D. dissertation.

April 16, 1975

Stanley Kiwor to Trustees

Letter is a request for purchasing information for some of Merton's books and pamphlets.

August 1, 1975

James Laughlin to Trustees

Letter is a correction to a typo in a letter sent to Dr. Petrik.

December 5, 1975

Raymond Bailey to Trustees

Letter is a proposal to write a commentary on *The Inner Experience*.

January 13, 1976

Trustees to Robert Daggy

Letter discusses what to do with Merton notebooks containing both non-confidential and personal material to allow scholars access to the non-confidential parts. John Laughlin's January 9, 1976 letter is included.

January 16, 1976

Tommie O'Callaghan to Trustees

Letter discusses scholar's use and separation of the Merton notebooks

April 1, 1976

Memo from Trustees

Letter contains the policy for the handling of Merton correspondence, working notebooks and holographic journals in the Merton Collection at Bellarmine.

June 25, 1976

August 3, 1979

September 27, 1979

Anne McCormick to Trustees

Note requesting reactions to letters between McCormick and Deba Patnaik about publication of a Merton photo-book.

October 18, 1979

Note requests a review of changing the title of *Thomas Merton on Peace to The Non-Violent Alternative*.
