That he is a pensioner, that he has not heretofore applied for this increase of myhis pension. That the number of the Pension Certificate which he holds is 805507, Act of June 27th 1890.

That he makes this declaration for the purpose of being placed on the pension roll of the United States under the provisions of the Act of February 6th 1907.
