Thanks for sending the Alanson Crosby story. I wonder if you got it from James Crosby? Yes, Mark Dunkelman (my co-author for the 154th Regimental) and I are very familiar with Crosby's account. His account is in his file at the National Archives, and as you can see from the copies inclosed we gave the story a paragraph in our book.

As far as I know it has not been published except for the History of Cattaraugus County. Comments: Your two Confederate issues were superb. Each article dealt with material culture - artifacts. The articles were exceptionally well researched and documented, some of the finest material ever published in the Journals. Crosby's account is strictly history - no good new materials on artifacts at all. As much as Mark and I love to see anything on the 154th New York Infantry published, I frankly do not think the Journal is the place for this article. This is only my opinion, you are the editor so you choose the articles you want to include.

You will have to go far to one-up the Confederate issues. And Yankee "stuff" is much better known than Reb although there are some good pieces "out there" that have not been written about - or well - yet. I do wish you the best of success on your Yankee issue (s).
