He was on the famous March to the Sea, in December, 1864, as sharpshooter to 20th A. C. His battle list includes Savannah, Bentonville. and all the engagements of North and South Carolina during Sherman's Campaign; he received his final honorable discharge in June, 1865, at Elmira, N. Y., at the close of the war; the maternal great grandfather and the grandfather of his wife served in in the Revolutionary War and the War of 1812; his maternal great grandfather, Granser Stratton, served in the Revolutionary War and was wounded by gunshot through the head. The ball entered near the eye, passing through the back of his neck, and he lived forty years after. His paternal great grandfather, Jonathan Foster, served in the Revolutionary War and the maternal grandfather of his wife, Russell Freeman, served in the War of 1812 and his widow drew a pension; her father, Abner Perry, served in 9th N.
