
I have recieved your kind letter of the 10th with great interest as I did not know that you were so activly interested in the 154th.

The item that I have which belonged to Private Goulding is his ID stencil which was recovered from the winter camp of the 154th in Stafford County, Virginia.. Just in case you did not check him out, Albert H. Goulding was a member of Company "F" of the 154th and dies of fever at the Army hospital at Brooke Station on 16 March 1863.

If you would like to have the stencil to make a copy of it just let me know and I will forward it to you or if possible that you may wait a bit for it, I will include it in the next batch of items that I photograph.

Hoping this has been of some information to you as the collecting of ID stencils and discs is my "main" Civil War interest, I remain,


I would appreciate it very much if you would let me know what address to send it to, the Institute or to your home?

Dear Mike,

I have received your kind letter of the 3rd and do hope that you and yours had a very Hapy New Years.

Am very happy that you are willing to wait until the Holdiday Rush in the PO dies down a bit, as it is really quite hectic and late up here even at this date the mail between here and Vermont is still four days late.

I will mail the 154th Stencil down in about a week and as you requested, it will be to your house.

I did ask a friend of mine down in Stafford County, Virginia who hunts just the Federal winter camps there if he had ever run across or had heard of anything that came out of the 154th site. He stated that as a camp in it's own right, there is none such, in fact the only thing that has been linked to the 154th there is my stencil.

I was very soor to hear of the pistol and you not being able to acquire it, it does hurt a bit. I have the ID disc of my great great grand uncle, Sgt. Jackson Sargent from Stowe, Vermont, it was recovered in Stafford a fewyears ago by a local hunter. I found his photo and the Medal of Honor that he won down at Petersburg up near Stowe but it turned out just like your case with the revolver, there was just no way that I could even come close to the woman's price.

Well, I guess that is about it for right now again, again I would like to wish you a very Happy New Year and also thank you for all of your most kind help and time which you have shown me.

GOULDING, ALBERT H.—Age, 22 years. Enlisted, August 29, 1862, at Arkwright, to serve three years; mustered in as private, Co. F, September 25, 1862; captured in action, May 2, 1863, at Chancellorsville, Va.; paroled, May 14, 1863, at City point, Va.; died of typhoid fever, May 18, 1863, in hospital; also borne as Golden.


Dear Mike,
