All pack animals etc. will cross the River with the trains and will rejoin the troops beyond Richmond.

This Army will move towards Alexandria tomorrow morning starting at 7 o'clock.

V. The 14th Corps in advance will move by way of Hanover Court House ford and Childesbury to a point near Chestnut Hill, then by the most direct road to Rappahannock Station on the Rappahannock River, then through New Baltimore, Haymarket, Centreville and Fairfax Court House.

VI. The 20th Corps will start at 10 a.m. and encamp tomorrow night on Brooke(?) Creek, and move thence by way of Ashland, Chilesbury, and Spottsylvania (sic) C.H. and will cross the Rappahannock at United States Ford, or any point between that and Rappahannock Station and will then move towards Alexandria through or near Catletts Station or Bruitsville(?).

VII. The troops will not be marched to exceed fifteen miles per day unless to reach a suitable camping ground.

In passing through Richmond the troops will take the roads indicated in the order of 8th inst. and will be marched in good order. The pack mules of each Brigade will be allowed to follow the Brigade through the city but the Head Quarters and Regimental Wagons will be marched on streets other than those taken by the troops and in such a manner as not to interfere with the march of either Corps.

VIII. The Maj. Genl. Comdg. will accompany the 14th Corps as far as Hanover C.H. and the 20th Corps thence to Alexandria.

IX. One half of the Pontoon Train will accompany each Corps.

Captain:

I have the honor to submit the following letter of advice:

From the date of last report the Brigade was continually on the move until the 10th inst. when it reached its present position. Since the latter date the Command has been actively engaged in doing guard and picket duty and in erecting fortifications.

The regiments are encamped as follows: The 73d Pa. V.V. and 124th N.Y.V. are intrenched on Johnsons Island in the Savannah River; the 109th Pa. V.V., 119th N.Y.V., 154th N.Y.V. and 33d N.J.V. are held as a reserve in rear of the 3rd Brigade on the west bank of the River.

The general condition of the Command is good. The troops presented a fair appearance at inspection. Clothing is well worn but requisitions have been forwarded for new supplies. Arms accoutrements and ammunition are in good condition with sixty (60) rounds per man.

Qr. Mr. Dept.

The transportation of the Brigade consists of 8 horses one hundred and forty (140) mules and twenty-three (23) army wagons. The jaded and almost broken-down animals which left Atlanta have been replaced by good serviceable mules captured on the route. The animals have been well supplied with corn, oats and fodder gathered from the country traversed.

Subsistence Dept.

The following rations have been issued during the month. Four and one half (4-1/2) rations of hard bread. Fifteen (15) of coffee, twelve of sugar, three (3) of bacon and full rations of fresh beef, salt, pepper, candles and soap. In addition to the above gov't rations of sweet potatoes, molasses, sugar, fresh pork, peas, beans, rice meal, flour, poultry and turnips were gathered from the surrounding country by foraging parties sent out from the Brigade.



Medical Dept.

The health and sanitary condition of the troops is good. Medical supplies are sufficient. Each regiment is furnished with a good pack mule to carry paniers (?).

The several departments of the Brigade generally/well conducted and their management reflects credit upon the officers in charge of them.

I have the honor to submit the following Letter of Advice:

Since the 22d day of July the Brigade has been in the trenches, about one and one-half miles from Atlanta, Ga., its left resting on a branch of Peach ~~Tree~~ Creek, on the farm of a Mr. Lendis.

The troops are encamped on elevated ground. The beds are either raised or placed upon boards. The streets and quarters are fairly policed; sinks have been properly located and every measure has been taken to promote both the health and comfort of the troops. Several springs and a running brooks supply the camps with water.

Means of supplies and communication are furnished by railroad to Vinings Station, and thence by wagon road to the Brigade.

There ~~have been~~ no irregularities or violation<sup>of</sup>/orders; all orders are promptly and cheerfully executed.

Adjt. Genl's. Dept.

The business of this department is conducted in an efficient manner.

Inspectors Dept.

The troops presented a neat and soldierly appearance at the monthly inspection; and considering the continued hardships and exposures of the campaign their condition reflects great credit upon the zeal and attention of their commanding officers. Camps are daily visited by the Brigade Inspector; all sanitary measures are enforced; unserviceable property promptly inspected and disposed of.

The Command is well supplied with clothing and equipments; there is no greater demand than for the usual monthly supplies. Rubber poncho blankets have frequently

been applied for but without success; a number are needed in the command.

#### Ordnance Dept.

Arms accoutrements and ammunition are in good condition with sixty rounds of the latter per man.

#### Qr. Mr. Dept.

The transportation of the Brigade consists of thirty-nine army wagons and two hundred and thirty-six mules whose average condition is good. The ten riding horses are in poor condition. Several good saddle horses are much needed at Brigade Headquarters.

All estimates for clothing, camp and garrison equipage have been filled except those for rubber blankets, regulation hats, drums and a few knapsacks.

#### Forage Dept.

Full rations of oats and corn chiefly of the former and of good quality have been issued.

#### Commissary Dept.

The following rations have been issued to the troops during the month:

Full rations of fresh and salt meat, hard bread, prepared mixed vegetables, coffee, sugar, salt, pepper, soap and candles; one ratio of whiskey and two of vinegar the latter of poor quality, have also been issued.

#### Medical Dept.

The Brigade Hospital is consolidated in the Division Hospital which is located a mile in rear of the camp.

The general health of the troops is fair with a slight increase of sickness since last report, of a malarious character. The sanitary and physical condition of the troops is good; a few symptoms of a scirbutic (?) nature are seen, but no diseases of a contagious character are prevalent. An increased supply of vegetable food is earnestly recommended by surgeons.

Each regiment of the Brigade is supplied with one pack mule and paniers (?) for medical purposes with the exception of the 119th N.Y.V. The surgeon of this regiment states that soon after starting on the campaign his mule broke down, and it being impossible to obtain another the paniers (?) were placed in the wagons and left at Ringgold. Measures will be immediately taken to provide the regiment with a mule and paniers(?). Medical supplies are sufficient; hospital accommodations are good.

#### Ambulance Dept.

The ambulance train consists of ten ambulances and one medical wagon with the necessary equipments. Two ambulances and four horses are required.

Gen'l. Orders No. 2 (series 1863) D.C. are complied with except so much as relates to a fully supply of ambulances and horses.

#### Latest Orders Received

Company and regimental commanders account properly for company and regimental funds.

Rations are prepared by company books in accordance with Genl. Orders No. 76 s. 1863 D.C.

No sutlers have been present (sic) with the command Co. T 27th Pa. V. having reenlisted as veterans and the regiment which was formerly attached to this Brigade have been mustered out at the expiration of its term of service it was assigned for temporary duty to the 73rd Pa. V. by order of the Maj. Genl. Comdg. Dept.

This company during its previous three years service was detached as guard at the Arsenal, Washington, D. C. I would respectfully suggest that this company be permanently incorporated with the regiment with which it is now serving.

Guards are well instructed in their duties and perform them satisfactorily. Pickets are ever watchful and vigilant, and we have yet to experience the first surprise of our picket line by the enemy. The pickets and posts are established on the most commanding positions covering every ravine, open field and approach to our lines.

Too high praise cannot be awarded the officers and men of this command for their cheerful performance of duty at all times and under the most trying circumstances, and for the bravery with which they have ever engaged the foe.

The ability and zeal of commanding officers in the Brigade is all that could be desired, and the different staff and administrative officers are fully competent to discharge satisfactorily the duties of their respective positions.

I have the honor to submit the following letter of advice:

Ohio Brigade composed of the 27th, 73d and 109th Pa., 119th 134th and 154th N.Y. and the 33d N.J. Vols. was formed pursuant to Special Field Orders No. 105 par. 4 Dept. of the Cumberland dated April 14, 1864.

The 27th Pa. Vols are encamped at Lookout Station on the Nashville & Chattanooga R.R. The 154th N.Y. Vols, 73d Pa. and 33d N.J. and 134th N.Y. Vols are encamped across the valley from Lookout Station and along the base of Raccoon (sic) Ridge. The 119th N.Y. Vols are encamped at Shell Mound Tenn. The 109th Pa. Vols. have reenlisted as Veteran Volunteers are absent on furlough.

A detachment from the 73d Pa. Vols consisting of two medical officers an Actg Qr Mr two Lieutenants and 144 men which had reenlisted and were furloughed Jan 12, 1864 returned Mar 30, 1864.

During the month the troops have been chiefly occupied in guard picket and fatigue duty.

Adjutant Genl's Dept.

The business of this office is promptly and correctly transacted.

Qr. Mr's. Dept.

The transportation of the regiments is consolidated in this Brigade and is under the immediate control of the Bridge Qr. Mr. The amount of transportation is as follows:

30 Army wagons, 178 mules of which number 7 are unserviceable and the necessary equipments. A contagious disease, the glanders, has been prevalent among the animals since March 20th when it made its appearance with a new supply of mules. Every precaution has been taken to prevent the spread of the contagion by removing the exposed animals to a distant point. As soon as the disease was fully developed the animal was immediately killed. 20 mules have died since March 20th principally from this disease. The animals are well cared for and are only used in the public service. Of the quality of the mules used in brigade transportation they are small, young and poor in flesh and do not appear to thrive on the forage issued. The Inspector makes frequent visits to the wagon train.

Forage Dept.

Full rations of grain are issued. The average mixture of forage is two thirds corn to one third oats. Scarcely any hay is issued.

Commissary Dept.

Full rations are issued to the troops consisting of all the regular articles composing the ration except fresh vegetables which is only a partial ration. A better supply of pickles or a substitute and of fresh vegetables is much needed. The rations issued are sweet and wholesome. A sufficient quantity of beef is issued but of a very inferior quality. Full rations of soft bread of good quality is furnished to the troops.



#### Ambulance Dept.

The ambulance train of this Brigade consists of 10 ambulances one army and one medicine wagon 2 horses and 7 mules in good condition and 4 mules unfit for hard service.

Gen. Orders No. 2 C.S. Dept. Com. are complied with except so much as relates to a fully supply of animals for which frequent requisitions have been made.

#### Medical Dept.

The regimental hospitals of this Brigade are consolidated into one and are well supplied. The accommodations for the sick are ample. A few cases of smallpox and measles have occurred during the month. Every possible precaution has been taken to prevent the spread of the contagion. Scurvy has also appeared in a few cases. A regular account of hospital fund is kept. The general health of the Brigade is fair. The daily average of sick in the Brigade during the month is 108 divided as follows:

Gen. Orders No. 8 C.S. Dept. Com. are complied with except so much as relates to providing each regiment with a pack mule to carry regimental hospital stores. Frequent requisitions have been made but no suitable animals for that purpose can be obtained. The Brigade hospital Dept. is supplied with one medicine wagon.

#### Provost Mar. Dept.

Good order is maintained in the command and all duties of this Dept. are properly performed.

#### Ordinance Dept.

All unserviceable ordnance stores have been inspected and either condemned to be dropped or turned in for repairs. Arms and accoutrements are kept clean and free

from rust and are properly cared for. Their appearance at inspection was faultless. The ammunition is in good condition and a good supply is on hand.

Inspectors Dept.

Daily visits are made to the regiments. The camps are clean and orderly well policed and ditched. The quarters are comfortable and neat. The troops are daily exercised in skirmish, company or battallion drill and target practice. All guards are mounted at nine A.M. in accordance with regulations. A portion of the Articles of War are read weekly to the troops also such extracts from the revised Army Regulations as will tend to promote the efficiency and discipline of the command. Recitations in Caseys Tactics for officers are held weekly by the regimental commanders. All the regiments of this Brigade have company cooks in accordance with regulations.

Clothing is in good condition. A supply nearly sufficient to fill all requisitions has just been received (April 20th). Regimental and company books are generally complete. All unserviceable quartermaster stores have been condemned.

Gen. Orders No. 115 War Dept. and Gen. Order No. 55 Dept. of the Cum. are the last orders received at this office. The following orders are needed to complete the files in the respective regiments: 73d Pa. Vols. All orders between No. 373 series of 1863 and No. 48 series of 1864 of War Dept. and orders of the Dept. of the Cum. between No. 239 series of 1863 and No. 43 series of 1864. 134th N.Y. Vols. War Dept. series of 1864 Nos. 10, 48, 50, 51, 52, 53, 54, 58, 66, 67, 71, 72, 73 and 75. Dept. of the Cum. No. 35.

~~Officers wear the uniform and insignia prescribed by Army Regulations in compliance with par. 3 Gen. Ord. No. 8 OS D.C. Regimental and company commanders account properly for their respective funds.~~

A Council of Administration organized in conformity with regulations convened and established the price of sutler's goods for this Brigade. Each regimental Sutler has been furnished with a copy and directed to place it in a conspicuous position in his tent. A list of articles and prices accompany this letter.

The 73rd Pa. Vet. Vols returned from furlough Mar 30th. The commanding officer of the regiment did not then and has not yet returned. It is very difficult to get a report or obtain correct information from the regiment as the regimental books and papers are not with the command. The Brigade Commander has forwarded to Dept. Hd. Qrs. a statement of its condition.

The supplies of this Brigade are transported by railway to Lookout Station.

So far as my observation extends the officers of this Brigade are capable and efficient and perform their duties ably with credit to themselves and to the command.
