The troops will be expected to appear in the best possible condition as they pass through Richmond in Review tomorrow. Caps and badges must be worn throughout, and the persons, clothing, arms, and accoutrements of the men be clean and neat.

The usual honors and salutes will be paid. Bands of Music will not wheel out in front of the Reviewing Officer. Companies will be previously equalized as usual.

All pack animals etc. will cross the River with the trains and will rejoin the troops beyond Richmond.

Circular:

As a standing rule during campaigns, after any change in the main or picket lines, Brigade Inspectors will report to this office promptly describing the new position, especially with reference to the lines on their right and left, and those of the enemy in front - sending with the report a diagram sketch of the position and general character of the grounds in front with roads and distances marked - the number of paces in extent of the main and picket lines - the disposition of the different regiments and the location of Brigade Head Quarters will be particularly designated and all other points of interest or information will be included.

Important information about the enemy or the roads or country in front or on flank, which may be obtained from any reliable source, will always be promptly reported.

Pains will be taken by all Inspectors to obtain as much of such information as possible.

Captain:

I have the honor to submit the following letter of advice:

There has been no change in the position of the Brigade since last report.

It is encamped on the south side of the City in the Enemy's entrenchments connecting on the left with the 3rd Brigade, 3rd Division and on the right with the 1st Brigade, 2d Division.

From the 15th of September until the 5th inst. the troops were chiefly engaged in drilling and in picket duty: since the latter date heavy details have been made from the command for work upon the fortifications of the city. On the 11th inst. two hundred and fifty (250) men and on the 16th five hundred (500) men left the Brigade on foraging expeditions being absent four days on each excursion.

The regiments are well and with the exception of the 33rd N.J. Vols. ^{fully} supplied with clothing, camp and garrison equipage.

In respect of condition of equipments proficiency in drill general health and morale and ability and zeal of commanding officers the Brigade is in an effective and satisfactory condition.

The different departments in the Brigade are properly conducted and with the exception of the transportation in the Quartermasters Dept. in an effective condition.

The transportation of the Brigade consists of thirty-six (36) mules of which number twenty five are unserviceable. The wagons and equipment are in good condition, but the condition of the mules is poor. Owing to the interruption in our communications, very little forage has been issued. The glanders which prevails in other commands has not made its appearance among the animals in this Brigade.

With the exception of salt meat full rations of the usual articles of good quality have been issued.

The average daily detail for guard picket and fatigue and the average daily number of sick in the brigade during the month is as follows:

Genl. Orders No. 15 C.S. Dept. Cum. are complied with except in the case of the 119th NY Vols. which has no pack mules or panniers. Action has been taken to supply this want.

Par. III Genl Order's No. 8 c.s. Dept. Cum. is complied with and generally dues observance is paid to regulations and existing orders.

Regimental and company commanders account properly for their respective funds.

The officers of this command are generally distinguished by ability attention to duty and zeal for the welfare of the service.

Captain:

I have the honor to submit the following letter of advice:

Since the inspection of May 21st this Brigade has been almost uninterruptedly engaged in marching, fighting or erecting fortifications. These protracted labors aggravated (sic) by exposure to heavy and incessant storms have produced their natural results in the physical exhaustion of the troops. But both officers and men though severely tried by the toils and exposure of the campaign are still zealous and determined and will cheerfully make whatever further efforts the exigencies of the service may demand.

Ammunition, arms and accoutrements are in good condition. The clothing is well worn and the men having had no opportunity (sic) for washing and being very poorly supplied with soap it is in a very uncleanly state. A new supply is much needed.

The troops have been supplied with full rations of coffee, sugar, bread and meat. The continued sameness in diet is severely felt, and symptoms of scurvy have appeared in the command owing to the total exclusion of vegetables from the rations.

The sanitary condition of the troops is as good as could be maintained under the continued exposure and fatigue. The lists of sick is made up of those who have failed rather through physical exhaustion than the attack of any prevailing disease.

At the opening of the campaign the mules in the transportation department were in poor condition and hard work with lack of forage has still further weakened them; a number of mules if much needed. There is also a want of horses for officers and mounted orderlies at these Hd Qrds.
