

Dear Dr. Meredith:

Dr. George Oldenbourg wrote to me a couple of days ago, before I got your letter, concerning the P.H. Jones pistol. It is amazing that you have had in such a short period of time two M1862 Police Colts, both inscribed to members of the 154th New York. Thank you for writing to me about the pistol, for sending the photographs and for your offer to sell it to me.

However, Dr. Meredith, I really do not believe you know that you and Dr. Oldenbourg are living in a different world than I am. Anyone who can afford to collect Confederate handguns, who advertises as such and who has his own stationary printed to reflect the same is not in the same class as a salried worker who last year made \$30,000.00. Very little, and I mean less than \$200.00 of that yearly salary went into my hobby, and that is obviously not collecting guns! As a matter of fact, \$2,500.00 is the price quoted to me for my daughter's two-year stint with Orthodontics that we just found out last month, and the Orthodontist goes to the same church I go to and told me he would give me a price I couldn't refuse! He may be able to buy guns (I don't believe he collects guns, however) but I sure cannot. Frankly, I could not even think of it if you offered the piece to me for \$500.00. Some of us poor folks must use all of our salary just to live and pay taxes.

Anyhow, enough for feeling sorry for myself. I would love to have the P.H. Jones pistol but I doubt if I will ever even have one unengraved Colt pistol, let alone one used by a Colonel of a regiment whose regimental history I wrote (and for which I have yet to realize any royalties!).
