In re: your letter of Sept. 10, 1975. I do have 43 letters written by Henry Van Aeram of the 154th N.Y.

We purchased the contents of his former home and in cleaning out a blind attic under the eaves we found them - in an open wicker basket where they had lain for 100 years. They were in very bad condition a lot of them unreadable stained eaten up etc & had to be destroyed. We were able to salvage these 43 and for over 2 months I pored over them and copied them off as I didn't want to handle them more than I had to. Some words where I left blanks in the copies were uncopyable

across them to be sure and get them back. ~~returning~~
they were returned 2 weeks before he died.

If you find these letters of any value for the
historical context we will mail the originals for
your appraisal.
