Opp-Fellows Hall Hospital, Washington, D. C., Feb. 19, '63

DEAR SIR :- I suppose long before this you are aware that your son, EDWARD SHULTZ, is no more. His brother had the satisfaction of secing him alive, having arrived about an hour previous to his death. I thought you might be gratified to hear more of the circumstances of his sickness and death than your son could give you. He was brought here six days before he died, and it soon became evident that his case was a severe one; his fever ran very high; his pulse beat at times 130 in a minute. He was most of the time delirious and seemed to suffer much, though he did not probably realize it. I perceived at once that he had been accustomed to think on religious subjects, and I took the first opportunity to converse with him. I began by remarking to him that he seemed to be a friend to Jesus. "Yes," said ho, "I have trusted in Him for a few years past, and I find it a good thing now-first-rate, first-rate;" repeating it with emphasis.
